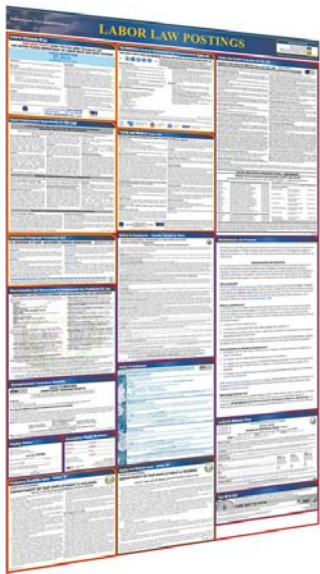


Labor Law Poster Subscription Program



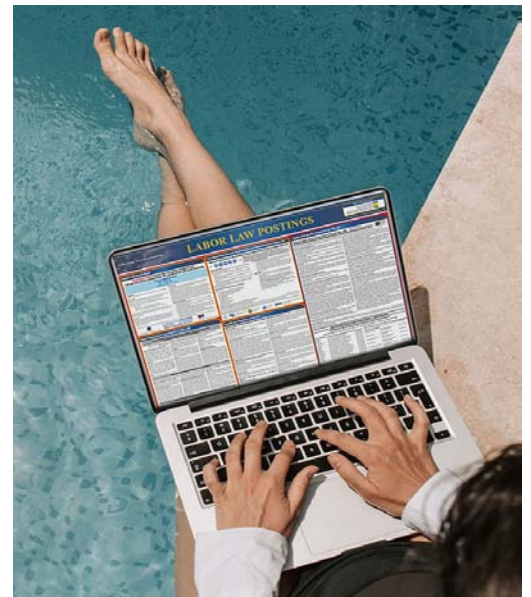
This is how our Labor Poster Subscriptions work:

1. Our compliance experts monitor federal and state labor law updates, and when labor laws change, posters are updated.
2. **Solution for Remote and Worksite Employees:** With ePosters, your staff is automatically emailed a link to access and review labor laws along with updates as labor laws change. Their eSignature is required to acknowledge receipt.
3. **Solution for Worksite Employees:** With laminated physical posters, when mandatory federal or state posters change, your replacement poster is automatically shipped to you. To remain compliant, replace your old poster with the new one.

Choosing both solutions is the ideal way to make sure your physical locations and remote workers are in compliance.

ePoster subscriptions are billed in blocks of 10 seats/users while the physical posters are billed per location.

Physical poster and ePoster subscriptions each have a one-time \$39 setup fee with a 3-month minimum commitment.
